# 14 July and 16 July 1996

2. The minutes of the Riccione meeting were accepted by general acclaim.

3. The Research Data Base was not progressing too swiftly. A problem was noted that the data was now a bit dated. The software developed looked satisfactory but the question of effective distribution remained unresolved. Hans Hausner had been in contact with Paul Holbrook on this issue but no further information was available at the meeting.

The meeting decided that Hausner be asked his opinion of the best way forward.

4. The committee should ensure they all are working from the most up to date version of the constitution. To this end Dale Niesz should send his most recent copy of the constitution to Bowman and Hart.

## 5. Education

An E-mail message from Desmaison indicated that the European Ceramic Society Educational Working Group was defining a policy on a WWW page and directory. Following their discussions in September 1996 propositions could be brought forward to the ICF.

## 6. Standards in Ceramics

Schneider reported that the work of this ISO group was still in its early phase but was suffering from a lack of active members. It was noted that Europe had not yet bought in.

Although the emphasis of the present concept was on mechanical/structural ceramics this could be broadened out to all advanced ceramics and could have an emphasis on environmental issues also.

7. A further enquiry from Palmonari requesting that Cerlabs be admitted to the ICF had been received. The feeling of the meeting was that organisations such as Cerlabs did not fit the entrance requirements of the ICF Constitution.

It was decided that the ball be thrown back into Cerlabs court by asking them to justify the grounds on which they seek membership. The issue is whether their constitution fits with that of the ICF. The members present reserved their judgement.

## 8. WWW Pages

This was strongly felt to be the way to go for information dissemination. Each member society/organisation should be encouraged to have their "pages" linked to the ICF home page. This entails that each member should have an interested and committed gatekeeper to keep relevant data up to date.

9. It was decided that Korea, who had been an observer for some time, should be asked to join the ICF. Their society should be sent a copy of the constitution and a formal invitation to join the ICF. It was noted that no further society members had joined the Federation following the original signatures at Maastricht.

## 10. PacRim Meetings

This set of biannual meetings had come into being as an off-shoot of the American Ceramic Society activities. There is no over-riding body who has PacRim in its "gift". It was felt that the ICF could have a useful role in soliciting

opinion as to the most suitable location for PacRim 4 in 2000 (Korea having taken PacRim 3 in 1998). It was reported via Mustafa Mansur that there was government support for Malaysia to host the PacRim 3 meeting. This issue should be taken up at the next committee meeting with respect to which countries/societies should be considered.

Action: Consideration at next ICF meeting

11. It was noted that the American Ceramic Society will have their centenary in 1988. Is there a way for the ICF to contribute to the celebration? Members are asked to consider this issue and bring forward ideas to the next meeting.

Action: All members

12. There was a feeling that little progress was happening in the ICF and that a review be made of the members as to what they wanted the ICF to be doing.

Action: Feedback from members to Secretary

13. A thorough review of the membership of the Executive and the Council should be made and new members should be sought. Metselaar will investigate relevant society status in the former USSR countries.

Action: All members

14. A nominating committee to oversee the next elections will comprise Metselaar, Hirano and Niesz. They will be able to co-opt one or two more members if required and Metselaar will chair and convene the committee.

15. The next Executive meeting will be held during the American Ceramic Society meeting in Cincinnati during the period 4 - 7 May 1997. The next council meeting and officer elections will be held at the European Ceramic Society, to be held at Versailles, France, during the period 22 - 26 June 1977.
