The Minutes of the previous meeting of the ICF Council Meeting, held on 20 Sept. 1998, which had been circulated, were accepted. However it was suggested that member's affiliation should be represented as the name of the academic society according to BYLAWS.

CORRESPONDENCE

President Hirano reported the new members of ICF; Bangladesh Ceramic Soc. on the basis of a national ceramic society and Nat. Res. Center Egypt on the basis of a national research organization.

Dr. Kim reported the summary of the Pac Rim 3 held at Korea and stated the acknowledgement for support. The attendance was 948 from 24 countries. (74% Domestic, 26% International (16% Japan, 3% U.S.A.)) President Hirano stated acknowledgement for the excellent meeting and admire a good success to Dr. Kim. It was confirmed that Pac Rim 4 will be held at Outrigger Wailea Resort, Wailea, Maui, Hawaii, Nov. 4? 8, 2001 in U.S.A. and Pac Rim 5 at 2003 in Nagoya.

4. CONSTITUTION AND BYLAWS

(i) Article 6: Officers of the Federation

The Article 6 of the constitution was confirmed to be revised as follows; The officers of the Federation is a President, Vice President / President Elect, Second Vice President, Secretary, immediate Past President, and a representative of the Member Organization which serves as the Secretariat.

(ii) Bylaw 6: Indemnification

It was noted that most "non-for-profit" organizations in the USA are taking insurance cover for officers. The Indemnification item was discussed with Mr. Paul Holbrook, the Executive Director of the American Ceramic Society and agreed that each officer should take out personal insurance.

Prof. Uematsu, chair of the committee, reported the current situation of the database of the ICF. He has already input the data of 1500 Japanese researchers of academies, schools, companies and national laboratories. Prof. Uematsu received the database in U.S.A. which was collected by Prof. Freiman. Prof. Uematsu asked the collection of data base to European and Korean members.

MEETING of COUNCIL of ICF

BRIGHTON, U.K. 20 June 1999

1. COUNCIL MEETING

The ICF Council Meeting was held during the European Ceramic Society Meeting and convened at 5 p.m. on 20 June 1999 in Room 3, Level 3 of The Brighton Centre.

4. CONSTITUTION AND BYLAWS

Professor Hirano introduced two items:

(i) Article 6: Officers of the Federation It was noted that Article 6 of the constitution reads as follows; The officers of the Federation shall be a President, Vice President / President Elect, Second Vice President, Secretary, immediate Past President, and a representative of the Member Organization which serves as the Secretariat. For the present, the Ceramic Society of Japan provides the Secretariat.

(ii) Bylaw 6: Indemnification

Following detailed discussion at the most recent meeting of the ICF Executive Committee (25 April, 1999), concerning the problems associated with indemnification of officers of ICF it was agreed that:

Bylaw ARTICLE 6 - Indemnification - should be deleted.

In the subsequent discussion of the constitution, it was agreed that

Bylaw 8 (e): Accounts and Expenditure -- should be deleted.

5. LISTINGS OF PROFESSIONAL SOCIETIES / OFFICERS

To ensure that the ICF membership records are kept up to date, all national societies were asked to confirm the names of representatives on ICF Council every 6 months.

(ii) Environment

Prof Hirano presented an oral report on behalf of Prof Yanagida; in the report he drew attention to Pac Rim 4 to be held in 2001, which would address environmental issues.

(iii) History of Ceramics

In a written report Professor Kingery stated that "Ceramics as a Global Enterprise" by M A Rasmussen and W D Kingery had been published by the American Ceramic Society.

(v) Standardization -

Dr Schneider provided the following written report 1999 STATUS OF ISO/TC 206 ON FINE CERAMICS

(Alternative Terms For Fine Ceramics Are Advanced Ceramics, Engineered Ceramics, or High Performance Ceramics)

Currently ISO/TC 206 organization structure encompasses 25 Working Groups covering development and approval of diverse standards. The 6th Plenary Meeting of ISO/TC 206 was held on 18-06-1999 at BSI in London, United Kingdom. Importantly a parallel joint coordination meeting between ISO/TC 206 (Fine Ceramics) and CEN/TC 184 (Advanced Technical Ceramics) was organized under the "Vienna Agreement Between ISO and CEN."

An agreement between ISO/TC 206 and CEN/TC 184 was reached and signed by each TC chairman (S. Schneider and B. Newland) on 18 June 1999. The agreement towards implementation include current and future work and their relationship to development of common business plans.

The 7th Plenary Meeting of ISO/TC 206 will be held at Ottawa, Canada on 18-08-2000; followed by the 8th Plenary Meeting at Maui, Hawaii, USA on 11-2001.

(v) Education Qualifications - No report

(vi) Research -

Information previously supplied by Professor Uematsu about the ICF Database was reiterated. Information on 1500 Japanese researchers (academies, schools, companies and national laboratories) have already been entered. Details of approximately 100 workers in the USA had been supplied by Prof. Freiman. In order to extend the database worldwide it was agreed that a mechanism should be established to enable individual workers and groups to input data directly on line. Once available it should be publicised widely.

It was noted that no new requests had been received for sponsorship of meetings by ICF. The future meeting were noted:

- (iv) AustCeram 2002, to be held in Perth, September 2002
- (v) Pac Rim 5 will be held in Nagoya, Japan from 29 September to 2 October 2003.
